I hereby request under the Local Government Official Information and Meetings Act 1987 the release of the following information:

1. How many requests for official information (LGOIMA) did the Council receive in the year 2023? 119

2. How many of them were handled within the statutory timeframe of 20 working days? 112 were handled within the statutory timeframe and this number includes 12 LGOIMAs that required extensions that were notified to the requestor.

3. Out of all responses to requests for official information in 2023, how many of them were made publicly available (e.g. on your website)? – to date 65 requests have been approved for public release.

4. How many of all the requests for official information in 2023 were refused on the grounds that these requests were "frivolous or vexatious or that the information requested is trivial" (see Section 17 (h) of Local Government Official Information and Meetings Act 1987)? 0

5. Were the people informed that their requests for information were refused under Section 17 (h) LGOIMA? n/a
