We refer to your official information request dated 9 November 2023 for staff information.

Your LGOIMA was a query to all Coast council and did NOT relate to the CCO's.

The information you have requested is marked below in red:

## How many staff do you have

- 73 FTE at 30 June 2023 – Reason for decrease from prior year is due to flood recovery staff who were on a fixed term contract in line with external funding being received for them, they have finished their contract.

How many staff did you employ this time last year - 83 FTE at 30 June 2022

How many earn over \$100,000 - 14

How many have served more than 10 years - 12

How many have served under one year – 15 (7 relates to flood recovery)

How many staff have retired or resigned this year - 41

Did any lose their job due to restructuring and if so how many - None

How many vacancies do you have currently have - 2

How challenging is recruitment compared to a year ago

- Due to the small population it is challenging to find staff with the required skillset in the District, and as such recruitment is a challenge, and in some cases the work will

be performed by external contractors. Due to increase workload as a result of flood recovery additional employees were employed and consultants contracted to assist with flood recovery work.

What sign on incentives are you offering.

- Depending on the circumstances, council may offer a relocation fee.

Please note: Of the 41 leavers, 9 were employed to assist with flood recovery work and was thus not employed on a permanent basis. To put the 41 leaver into perspective as at 30 June 2023 there were ~92 positions at Buller District Council which is a mix of full time, part time and fixed term and permanent employees.
